Proposed Amendments, Deletions and Additions to Rules in the Constitution:

RIGHTS & PRIVILEGES OF SPORTING MEMBERS

This category of membership is open to individuals ~~who are 12 years and above and~~ who **shall** represent the Club in competitive sports. They will enjoy restricted privileges which shall be determined by the Management Committee from time to time. They will not be entitled to vote at any meeting. Their Membership shall cease upon their ceasing to represent the Club in competitive sports. The Management Committee shall at its absolute discretion determine when the Sporting Member shall cease to be such a member.
