(D) TERMS & CONDITIONS

1. Please submit the below documents:
 - a. One(1) passport-sized coloured photograph for each applicant.
 - b. Photocopy of birth certificate for the child and marriage certificate for spouse you are applying for.
2. The monthly subscription fees of \$40.00 (subject to GST), for spouse and \$20.00 (subject to GST) for each child above 12 and below 21 years of age, will be charged to your account upon approval of application. This fee may vary as the Committee may determine from time to time.
3. Please note that Family Spouse/Children memberships cannot be terminated within six (6) months of the application date.
4. Re-activation only applies with pre-records in Membership ClubE system.
5. For re-activation within 6 months of the termination date, \$10.00 (subject to GST) will be charged for a replacement card, while requests made after 6 months will have the charge waived.

(E) RULE 15 OF SRC CONSTITUTION - EXTRACT

- a. The spouse and children (who are below 21 years of age) of an Ordinary (Transferable), Ordinary (Non-Transferable) Member may apply to become Family (Lady/Gentleman) / Family (Junior) Members provided the spouse and children are residing with the member. Such membership will cease if the spouse is separated or divorced. In the event of the demise of the spouse, the Committee shall review such membership accordingly.
- b. The Family (Junior) Member will pay a subscription fee as may from time to time be determined by the Management Committee. The Family (Junior) Member upon attaining the age of twenty-one years may apply to become a Ordinary (Transferable) / Lady (Transferable) Member and the Committee may approve such an application only if:
 - i) a vacancy exists
 - ii) he pays the requisite Entrance Fee, Transfer Fee (if any) and deposits applicable at the time of application.
- c. If he does not, upon reaching twenty-one (21) years apply to become an Ordinary (Transferable) / Lady (Transferable) Member or if he is not accepted for Ordinary (Transferable) / Lady (Transferable), he shall cease to be a Member of the Club.
- d. A Member shall be responsible for all debts due to the Club incurred by his spouse or children who are family members.

I also agree that I shall be bound by the Club's Rules and Bye-Laws and other regulations currently in force, and those that may be added or amended by the Club from time to time as it may consider appropriate.
